- 1) That the draft agreement between the cities of Melville, Fremantle and Canning for implementing the phase 2 due diligence process be received.
- 2) That Council give in principle support to the following process to support the key principles of the agreement and the transition of RRG's assets and operations:
  - (i) Settle litigation brought by the City of Canning in relation to residual asset values from the RRC project;
  - (ii) Give notice to terminate the Canning Vale Centre Ground Lease and leave all improvements on the land;
  - (iii) Wind up all projects and the RRG in an orderly and timely manner including:
    - RRRC Project;
    - Office Project;
    - RRG entity;
  - (iv) Terminate all contracts and where applicable novate relevant contracts to third parties; and
  - (v) Dispose of surplus stock and unfixed assets.
- 3) Council acknowledge that:
  - (i) Under the agreement the City of Canning whilst acting on behalf of the Collective as Principal will invite requests for proposals to operate and maintain RRRC Project assets currently owned by RRG; and
  - (ii) Subject to the terms of the agreement if the lease is surrendered then ownership of the relevant RRRC Project assets will pass to the City of Canning.
